## **CONCEPT NOTE: IIPFCC Caucus Meetings At COP24**

## **Background**

- 1. The Declaration on the Rights of Indigenous Peoples (the Declaration, see A/RES/61/295), adopted by the General Assembly in 2007 is considered a milestone in the recognition of the rights of Indigenous Peoples. It is the result of an open and inclusive process of dialogue and negotiations among and between member states and Indigenous Peoples. The General Assembly sought to continue and build on this achievement by 'deciding to organize a high level plenary meeting....to be known as the World Conference on Indigenous Peoples, to be held in 2014 (See A/RES/65/198, paragraph 8). This reflected the ongoing 'concern' of the General Assembly, 'about the extreme disadvantages that Indigenous Peoples have typically faced across a range of social and economic indicators and about the impediments to their full enjoyment of their rights' (See A/RES/65/198, preamble)
- 2. The United Nations Framework Convention on Climate Change adopted the Paris Agreement (See 1/CP.21) in 2015, the Agreement outlined ambitious efforts to combat climate change, counting 5 specific references to Indigenous Peoples and their traditional knowledge, including the establishment of a traditional knowledge platform (See 1/CP.21, paragraph 135). Parties recognized the need to strengthen knowledge, technologies, practices and efforts of local communities and indigenous peoples related to addressing and responding to climate change and established a traditional knowledge platform for local communities and Indigenous Peoples (LCIP platform) for the exchange of experiences and sharing of best practices on mitigation and adaptation in a holistic and integrated manner.
- 3. The 24th session of the Conference of the Parties (COP24) is expected to finalize the rules for implementation of the Paris Agreement on climate change under the Paris Agreement work programme (Paris Rulebook), as well as to conclude its considerations on the modalities for the work programme of the facilitative working group by making recommendations to COP24.
- 4. Building upon the common practice of the previous the International Indigenous Peoples Forum on Climate Change (IIPFCC), the convening forum for the Indigenous Peoples Organisations (IPO) constituency, it organizes coordination meetings and briefings: e.g. a 2-day preparatory meeting and daily morning meetings.

#### **Objective**

- 5. The main objective of the IIPFCC caucus meetings (indigenous caucus) is to further the implementation of the 5 references to Indigenous Peoples in the Paris Agreement, and to coordinate internally towards participating in and informing the decision-making process of COP24.
- 6. To discuss emerging climate change priorities and continue to improve the organizational matters of the indigenous caucus.

#### **Participation**

- 7. A wide range of representatives from Indigenous Peoples' Organizations are expected to attend COP24.
- 8. Caucus meetings are open to representatives of Indigenous Peoples.
- 9. Simultaneous interpretation into English, Spanish, French will be provided.
- 10. Parties, UN agencies constituency representatives and other non-indigenous representatives interested in attending any caucus meetings are requested to respect the processes of Indigenous Peoples, and require the approval of the co-chairs prior to entering caucus meetings.

  - Key objective of COP24, the adoption of the implementation guidelines of the Paris Agreement.
- 15. Local Communities and Indigenous Peoples platform
  - The adoption of the modalities of the work plan of the facilitative working group
- 16. Other relevant emerging themes
